The project must be for new construction, renovation or beautification that does not require permitting.

The project must be able to be completed within this calendar year.

- take photos and video during the project and upon completion
- distribute a press release and photos of the completed project
- submit the project for industry or community awards

### **PART II - Required Documentation**

The following documents are required for funding consideration

- ☐ A full description of the proposed project. Please be as specific as possible.
- ☐ Photos of the existing space, pathway to the space, adjacent areas that may be affected, etc.
- ☐ A copy of the applicant's charter and bylaws, as a non-profit organization in the State of Florida.
- ☐ Certificate or other document showing active status of the Corporation with the Secretary of State.
- ☐ A list of Board of Directors/Trustees.
- ☐ A Form 990 or set of Financial Statements prepared or audited by a Certified Public Accountant for the current and previous Fiscal Year.
- ☐ Proof that the applying non-profit organization has been in business for five years or more.
- ☐ A copy of your IRS Tax Exemption Letter.
- ☐ Proof of current property and liability insurance.
